Sl. No.	The school is directed to ensure that:
1	The total number of sections of the school from class I to X shall be restricted to 19. The optimum number of students shall be restricted to 40 for a classrooms size of 500 sq ft and above. Further, the increase of sections shall be subject to specific approval of the Board based on the request of the school as per affiliation by law and availability of classrooms of greater than 500 sq ft dimension
2	The school is directed to run atleast 01 section each of bal-vatika I, II & III subject to the maximum bal-vatika permitted vide Board's circular no. 12/2023 dated 24-03-2023 & 25/2023 dated 11-09-2023.
3	The school is required to procure more books for library as well as create a separate reading space in library for staff and submit the videographic compliance within 03 months.
4	The mathematics lab is under stocked and the workstations in the labs are covered with cloth, which is not appropriate. Further, in the composite science lab, plastics stools are being used for seating in place of proper lab stools. Thus, the school is required to required replace the plastics stools with wooden stools in the composite science lab and upgrade the mathematics lab and submit the videographic compliance within 03 months.

The school shall conduct training of its teachers with CoE Bhopal within 03 months
and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- 1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.

- 5. The school shall renew mandatory certificates from time to time.

All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
